The Meeting was conducted in accordance with the circulars issued by the Ministry of Corporate Affairs ('MCA') and the Securities and Exchange Board of India ('SEBI').

Mr. Parthrajsinh Harshadsinh Rana (DIN: 06422789), Chairman of the Board, chaired the Meeting. Members were given facility for voting on PURVA Platform through remote e-voting between e-voting period from 08th September, 2026 to 10th September, 2026. Members were also informed that the facility for voting on PURVA platform is open for the shareholders who have not voted through remote e-voting earlier and will be continue to be available till 15 minutes after the conclusion of the meeting. Members were requested to vote as voting line was open.

The Annual Report including AGM Notice was e-mailed to the Members whose email ids were registered with the Company/ Depositories and the same was uploaded on the website of the Company, BSE Limited and PURVA. Furthermore, Pursuant to Regulations 30 of the SEBI Listing Regulation, we wish to inform you that in compliance with Regulation 36(1)(b) of the SEBI Listing Regulations, the Company has dispatched letters to those Shareholders whose e-mail addresses are not registered with Company/Registrar & Transfer Agent/Depository Participants, providing the weblink of Company's website from where the Annual Report for FY 2025-26 can be accessed.
3. The Company had availed the services of PURVA to provide the facility of remote e-voting.
4. The Board of Directors has appointed Ms. Prity Bishwakarma, Practicing Company Secretary, as the scrutinizer to supervise the e-voting process of AGM in a fair and transparent manner.
